

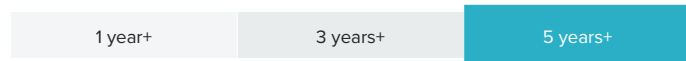

### FUND OBJECTIVE

The fund aims to provide long-term capital growth by tracking the performance of the top 40 companies listed on the JSE Securities Exchange (JSE).

### WHO IS THIS FUND FOR?

This fund is suitable for investors who want to grow capital over the long term by tracking the FTSE/JSE Top 40 Index. The investor can tolerate stock market volatility.

### INVESTMENT MANDATE

The fund tracks the FTSE/JSE Top 40 Index as closely as possible and invests in shares included in the index. The portfolio is tailored to match the performance of the FTSE/JSE Top 40 Index, but other securities will be held to offset high inflows and index fluctuations. Derivatives may be used for efficient portfolio management purposes.

### REGULATION 28 COMPLIANCE

The fund aims to achieve long-term inflation-beating growth, and therefore may hold a higher allocation to equities than what is allowed in terms of Regulation 28 of the Pension Funds Act. This fund is therefore not Regulation 28 compliant.

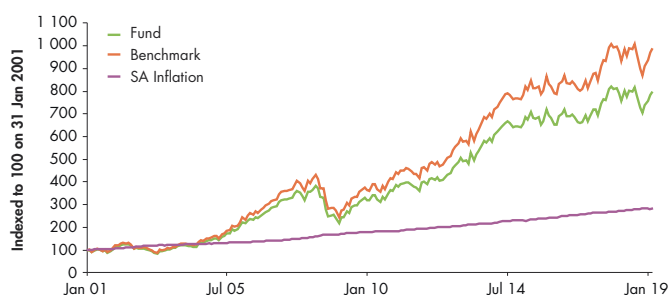

### Performance Since Inception

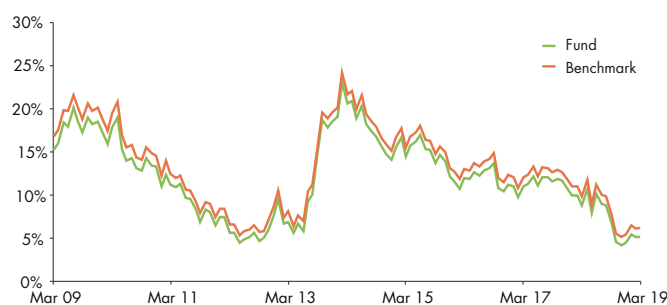

## FUND COMMENTARY as at 31/03/2019

The Old Mutual Top 40 Fund tracks the FTSE/JSE Top 40 Index and its shareholdings replicate the constituents that make up this benchmark. At month-end the benchmark sector allocation was as follows:  
 Resources : 28.05%  
 Financials : 19.94%  
 Property : 2.05%  
 Industrials : 49.94%

Cash exposure in this fund is kept as low as possible to give investors the full benefit of being invested in equities. Investment flows are matched with the corresponding market transactions on a daily basis to ensure that the performance of the fund is in line with its benchmark. Futures contracts are used, when appropriate, to minimise trading costs and gain exposure to equities.

Long-term investors choose this fund because they are looking for a pure equity fund and are cost conscious. Investors seeking consistency can use this fund as their core portfolio strategy and assign smaller portions to other investment vehicles that aim to outperform the market.

The FTSE/JSE Top 40 Index returned 8.45% over the quarter and 1.94% for the month of March 2019. The Mid and Small Cap Index returned 2.76% and -3.41% respectively for the quarter and -1.82% and -2.71% for the month of March 2019. Basic materials and consumer goods were the biggest sector performers this quarter with 18.04% and 12.38% respectively. The worst performing sectors were healthcare and industrials, with returns of -12.70% and -3.90% respectively.

Among the top performing shares for the quarter were Anglo American Platinum Ltd, British American Tobacco Plc and Capitec Bank Holdings Ltd, with returns of 36.8%, 27.4% and 20.8% respectively. The worst performing shares were Aspen Pharmacare Holdings Ltd, Mr Price Group Ltd and Sappi Ltd, with returns of -31.0%, -23.0% and -18.4% respectively.

The fund rebalances once every quarter in line with the index. There were two constituent additions to and two constituent deletions from the FTSE/JSE Top 40 Index, which rebalanced as at close on Friday, 15 March 2019.

TER is a historic measure of the impact the deduction of management and operating costs has on a fund's value. - Unit trusts are traded at ruling prices, may borrow to fund client disinvestments and may engage in scrip lending. The daily ruling price is based on the current market value of the fund's assets plus income minus expenses (NAV of the portfolio) divided by the number of units on issue.
- The Net Asset Value to Net Asset Value figures are used for the performance calculations. The performance quoted is for a lump sum investment. The performance calculation includes income distributions prior to the deduction of taxes and distributions are reinvested on the ex-dividend date. Performances may differ as a result of actual initial fees, the actual investment date, the date of reinvestment and dividend withholding tax. Annualised returns are the weighted average compound growth rates over the performance period measured. Performances are in ZAR and as at 31 March 2019.
